
PROPOSAL:

Firstly, to permit a 16 unit multi-unit development across three parcels zoned 'C' Commercial. Secondly to vary the required rear yard from 25 ft to 10 ft and the required east side yard from 25 ft to 10 ft.

REASON:

The proponent wishes to construct a 16 unit multi-unit development across three existing parcels. The development requires conditional use approval. Additionally, the proposed development encroaches on the required east side yard and north rear yard.

ZONING:

You are welcome to attend the public hearing to make a representation on the matter to be considered, however, you are not required to attend. If you cannot attend but would like to make a representation, you may file a written submission in person or via email with the Rural Municipality of Hanover prior to the public hearing. What happens at the public hearing?

At the time and date noted on the reverse of this page, the proposed application will be presented to Council. Council can ask the applicant questions about their application and they will then provide an opportunity for anyone to speak either for or against the application. Please keep presentations to no more than 5 minutes in length.
